The action has three SMART objectives: Support market restoring to normal (GO), Enhance competitiveness of the PDO/PGI wines in question and of the Greek and Romanian PDO/PGI wines in general (O1) and Increase the awareness and recognition of Union PDO/PGI scheme for wines (O2).
